

APPLICATION FEE WAIVER REQUEST

Full-Time MBA Program, Fall 2017



MBA applicants may request application fee waivers if they meet **both** of the following criteria. You must:

1. Be a U.S Citizen or U.S. Permanent Resident.
2. Meet the Program-Based or Financial Need-Based Eligibility requirements (see below).

Program-Based Eligibility

To qualify for Program-Based Eligibility, you must be **one** of the following:

- **An active participant of the AmeriCorps or Peace Corps.** Applicant must submit verification of participation in the program for the current year, such as a letter bearing the signature of the program director or adviser, or a copy of the current contract. You do not need to submit financial information.
- **A U.S. military service member.** U.S military service members (active, veteran, or honorably discharged) are eligible for a fee waiver. Please include documentation of service or certificate of eligibility. (Do not submit a copy of your military ID.)

Financial Need-Based Eligibility:

Financial need-based eligibility is determined by Estimated Family Contribution (EFC). To qualify, you must:

1. Complete the Free Application for Federal Student Aid (FAFSA) at <https://fafsa.ed.gov/>
2. Send us a screenshot or scanned copy of your Estimated Family Contribution (EFC), which can be found on the final page of the online FAFSA form.

When you receive your Student Aid Report (SAR) from FAFSA, send a scan to us as soon as possible. Be sure to black out your Social Security Number (SSN) before sending the required supplemental documents.

Requests for a fee waiver must be received at least five (5) business days prior to the application deadline for which you are applying.
